

**FIRST ADDENDUM TO AGREEMENT BETWEEN
THE CITY OF CITRUS HEIGHTS
AND
SUNRISE RECREATION AND PARK FOR
SUPPLEMENTAL LAW ENFORCEMENT
SERVICES**

This First Addendum (the “Addendum”) to the Agreement Between the City of Citrus Heights (the “City”) and Sunrise Recreation and Park District (“District”) for Supplemental Law Enforcement Services dated May 1, 2019 (the “Agreement”).

WHEREAS, on April 15, 2024, the City of Citrus Heights provided notice to District that the City entered into a new working contract for their officers and sergeants, which increased cost per officer who would be utilized by District pursuant to the Agreement.

WHEREAS, section 4 of the Agreement requires the District to pay for the services provided under this agreement as set forth in Exhibit A “Rate Matrix”.

WHEREAS, section 17 of the Agreement identifies no amendment, modification, alteration or variation of the terms of this Agreement shall be valid unless in writing and signed, acknowledged, and approved by both parties.

NOW, THEREFORE, in consideration of the matters contained in the Agreement and this Addendum, it is mutually agreed as follows:

Effective June 1, 2024, the following sentences in Exhibit A shall be stricken:

“Armed/Uniformed Police Officer w/ Marked Police Vehicle, up to \$95 per hour.”

“Holidays, up to \$95 per hour

And replaced with:

“Armed/Uniformed Police Officer w/ Marked Police Vehicle, up to \$115 per hour.”

“Holidays, up to \$115 per hour

Effective June 1, 2024, section 15 within the Agreement shall be stricken:

15. Notices: Any notices required to be given under this Agreement shall be in writing and shall be delivered either by (i) certified mail, return receipt requested, in which case notice shall be deemed delivered three (3) business days after deposit,
